Border Wall

U.S. Customs and Border Protection announced the first border wall contract of Donald Trump's second term, awarding \$70 million worth of work to California-based Granite Construction Co. to erect seven new miles of wall. Construction will take place in Hidalgo County, Texas. The Border Patrol agency said that the area being targeted routinely "experiences large numbers of individuals and narcotics being smuggled into the country illegally." https://tinyurl.com/2bnhotj4

Deportations

Salvadoran President Nayib Bukele announced his country's acceptance of hundreds of Venezuelan gang members who were illegally living in the United States on March 16th, releasing footage of their arrival and celebrating the development as a win for public

Donald Trump invoked the Alien Enemies Act of 1798, which allows the deportation of natives and citizens of an enemy nation without a hearing, making the move possible.

Reduction of the Federal Bureaucracy

Trump campaigned on reducing the Federal Bureaucracy and on Feb. 19, 2025 he issued a directive to reduce the size of the federal government, eliminate non-essential agencies and advisory committees, and minimize statutory functions to the lowest level required by law. https://www.federalregister.gov/documents/2025/02/25/2025-03133/commencing-the-reduction-of-the-federal-bureaucracy

On March 14, 2025 he issued an order that named seven agencies that were slated for elimination: the Federal Mediation and Conciliation Service, United States Agency for Global Media, Woodrow Wilson International Center for Scholars, Institute of Museum and Library Services, United States Interagency Council on Homelessness, Community Development Financial Institutions Fund, and the Minority Business Development Agency. Department of Education Investigations

The U.S. Department of Education has opened investigations into 45 universities accused of violating Title VI of the Civil Rights Act of 1964 by participating in programs or activities that allegedly discriminate based on race, the department announced on Friday, March 14. "The Department is working to reorient civil rights enforcement to ensure all students are protected from illegal discrimination," U.S. Secretary of Education Linda McMahon said. University of Michigan - Ann Arbor is under investigation for allegedly engaging in race-exclusionary practices in their graduate programs and Grand Valley State University is under investigation for alleged impermissible race-based scholarships and race-based segregation.
