Reports from Federal & State Elected Officials -

-Emmah Coker representing John Moolenaar reported the Congressman voted in favor of HR4, the Recession Act of 2025, which sent 9.4 billion dollars to the federal government that was identified as wasteful spending. The Congressman recently introduced the Line-5 Act, which would ensure that Line-5 remains in use and prevents future administrations from shutting down this international pipeline. Emmah gave an update on the TB legislation and the entertained questions from committee members. -Sheila read report from Senator Jon Bumstead regarding bats and that the Michigan Bat Roost Monitoring Program is asking residents to report roosting activity on their property or on public land. Reports from County Elected Officials & D-2 Member -

- -Prosecutor Beth Hand reported she hired a new Chief Assistant, Mark Webb, who started June 2nd. Mark has approx 34 years in as a lawyer and 20 years in prosecutions. Beth also shared some salary increases that were approved by the Board of Commissioners.
- -Sheriff Kim Cole spoke on his trip to Florida for the National Sheriff's Conference, the 2 hour Border Security meeting with Tom Holman and how 1,400 sheriffs swore in DJ Daniels and deputized him. Sheriff Cole spoke some on the Michigan AG wanting all officer involved shootings to be run through the AG's office. Sheriff Cole shared this will be the last year for him to lead the 4th of July parade. -Sheila read report sent from County Clerk Cheryl Kelly with info and concerns on "Ranked Choice Voting". This topic led to good discussion.
