- **A1)** Charles Robinson gave the overview on the D2 Caucus & State Convention. Sheila added the new MRP Chair is Senator Jim Runstead, Co-Chair is Bernadette Smith, Outreach VC is Rola Makki, Ethnic VC is Mike Farage, Grassroots VC is Chris Long, Coalitions VC is Sue Kokinda, Youth VC is Krish Manthrani and Administrative VC is Cheryl Constantino. Brittany Carsten also made the D2- Committee.
- **A2)** Nicole Norton gave an update on best days for the trip being in communication with Representative Joe Fox and still working on whether the need will be for one or two vans and the number of days for rental. Sheila added Brittany has not heard back from public schools as of today. Nicole added some time in April is being considered and does have the waiver completed for the parents to sign.
- A3) Sheila reminded everyone that memberships are due 30 days after January meeting.

#### **New Business:**

- **B1)** Discussion opened on the LDD 2025 on venues (Graystone Event Center, Scotty's, Stix), speakers, and what month to hold the event.
- **B2)** Sheila shared that Chairman Jay DeBoyer announced a new tip-line that Michigan citizens can use to anonymously submit suggestions for oversight investigations <a href="https://mioversight.com">https://mioversight.com</a>
- **B3)** It was reported that on February 13<sup>th</sup> the US Dept of Education cancelled over \$350,000,000.00 in contracts and grants to several regional educational laboratories and equity assistance centers and on February 17<sup>th</sup> it announced it has terminated over \$600,000,000.00 in grants to institutions and non-profits that were using taxpayer funds to train teachers and education agencies on divisive ideologies.

- **B3)** Sheila reported on the End DEI in Education and the portal (<a href="https://enddei.ed.gov/">https://enddei.ed.gov/</a>) for parents, students and teachers to report discriminatory practices carried out under the banner of diversity, equity and inclusion.

- **B5)** It was recommended to check out the DOGE website (<a href="https://doge.gov/regulations">https://doge.gov/regulations</a>) where they try to keep the public updated.
- **B6)** Sheila reported on Sanctuary Jurisdictions and where the DOJ stands.

## Reports from Federal & State Elected Officials -

- --Senator Bumstead reported in Lansing right now that Dems are still in charge of the Senate. House Republicans have started working on Budgets and Committees. He also spoke some on the Gun Safety Bill-58, protecting paid leave, the importance of getting a Republican Governor in office and the goal of lowering both income and corporate taxes.
- --Emmah Coker reported that Congressman Moolenaar introduced the Boost Act with Congressman Bishop that would provide a \$300 tax credit to rural households to expand internet access. Moolenaar also reintroduced the Supporting Farm Operations Act, voted in favor of the Budget Resolution and lastly along with Congressman Walberg they called on Eastern Univ, Oakland Univ and Univ of Detroit Mercy to end their partnerships with Chinese universities. Emmah then entertained questions from members which led to good discussion.
